**EQUIPMENT RENTAL & LIABILITY RELEASE AGREEMENT**

I acknowledge that I will be the only person using the equipment listed on this form during this rental period. I accept for use **AS IS** the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this form, but not returned to the shop. I acknowledge my obligation to return the equipment by the agreed date in clean condition and agree to pay for any repairs in the event the equipment is damaged beyond normal wear and tear.

I understand that the binding system cannot guarantee the user's safety. In downhill skiing, the binding system will not release at all times or under all circumstances when release may prevent injury or death, nor is it possible to predict every situation in which it will release. I further agree and understand that downhill skiing binding systems may reduce, but not eliminate the risk of injuries to my lower legs. However, I agree and understand that this system does NOT REDUCE THE RISK OF INJURIES TO MY KNEES or any other parts of my body. In snowboarding, cross-country skiing, snowblade and snowshoe use, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation. As such I freely agree to assume and accept any and all known or unknown risks of injury while using this equipment.

I understand that the sports of skiing, snowboarding, snowblading, snowshoeing and other recreational activities involve inherent and other risks of INJURY and DEATH. I voluntarily agree to expressly assume all risks of injury or death that may result from skiing/snowboarding/snowshoe/snowblade use, or which relate in any way to the use of this equipment.

I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slow speeds. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I AGREE TO RELEASE Maison de Ski, its employees, owners, affiliates, agents, officers, directors, and the manufacturers and distributors of this equipment (collectively "PROVIDERS") from all liability for injury, death, property loss and damage which results from the equipment user's participation in the sport of skiing, snowboarding, snowblade or snowshoe use, or is in any way related to the use of this equipment, including all liability which results from the NEGLIGENCE of PROVIDERS, or any other person or cause.

I further agree to defend and indemnify PROVIDERS for any loss or damage, including any that results from claims or lawsuits for personal injury, death, and property loss and damage related in any way to the use of this equipment.

This agreement and any claims shall be governed by Colorado law and the exclusive jurisdiction and venue for any claim shall be in the Clear Creek County Colorado District Court. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.
